**General Notice  
Issued by Dubai Municipality  
Regarding the Disposal of Fats, Oils and Grease Wastes.**

M/S Company - Association.....

Pursuant to the provisions of the Local Order No. (8) of 2002 A.D. regarding the drainage and irrigation in Dubai and the Administrative Decision No. (181) of 2007 A.D. concerning the wastes of fats, oils and grease, the Department of Drainage and Irrigation in Dubai Municipality kindly requests your establishment's cooperation on the following matters:

- 1- Please refrain from draining the waste of fats, oil or grease into drainage network.
- 2- You are kindly requested to install grease traps and interceptors to separate the fats, oils and grease, in conformity with the requirements and specifications approved by the Dubai Municipality. In the interest of public health, we encourage you to maintain them by regular cleaning.
- 3- Contract with duly approved and authorized cleaning companies to carry out the cleaning, maintenance and transportation of the grease traps and interceptor waste. The cleaning companies require prior authorized and certified license from the Dubai Municipality for the cleaning and transportation. A certified license must be presented to the Dubai municipality (Alserkal Envirol Recycling Plant) in the Al Aweer Area prior to disposal for treating the waste fats, oils and grease.
- 4- You are required to produce a monthly report containing all the data related to removing waste in grease traps, including the date of collection, quantity and the name of the company which cleaned and collected the waste (For reference, all restaurants will receive Monthly Report Format). A copy of the report should be sent to the Dubai Municipality (Alserkal Envirol Recycling Plant) by fax: 043209686 or e-mail [OTP@Alserkal-group.com](mailto:OTP@Alserkal-group.com) or submitted directly to the Dubai Municipality (Alserkal Recycling Plant beside) DM Sewage Treatment plant. As reference, the company is requested to keep a copy of the report to show to the DM inspectors
- 5- The contracted grease trap services Companies need to provide a copy of the discharged waste report to Dubai Municipality (Alserkal oil treatment plant), all collected waste must be delivered to Dubai Municipality (Alserkal Oil Treatment Plant) in Al Aweer.

Dubai Municipality looks forward to receiving your cooperation on the above requirements. Please note that any failure to adhere to the above requirements may result in the enforcement of Dubai Municipality Regulations, which may result, in addition to the penalty of a financial fine, in ceasing your services and suspending any permission granted to practice the activity resulting in closure.
